### SaaS Simplicity

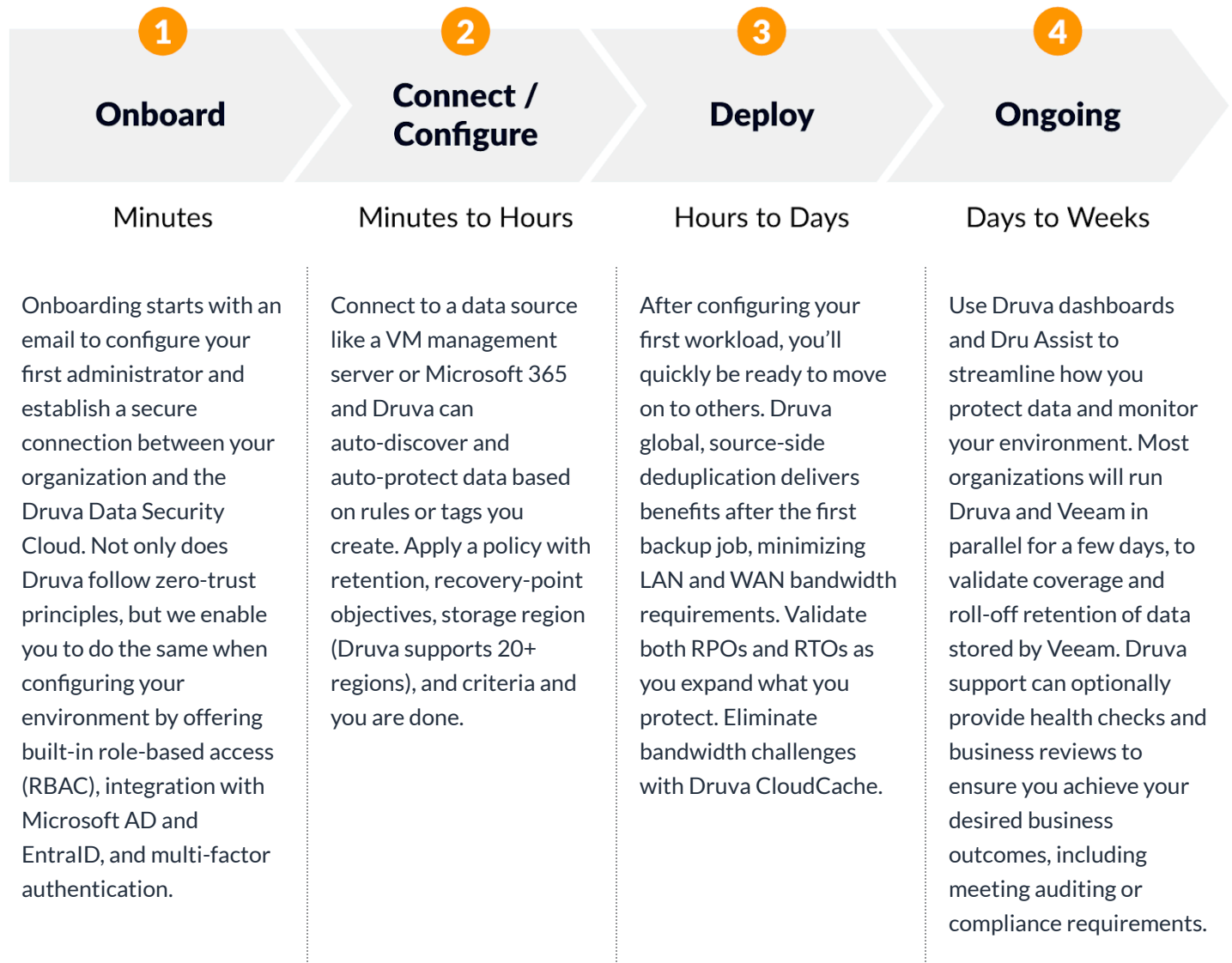

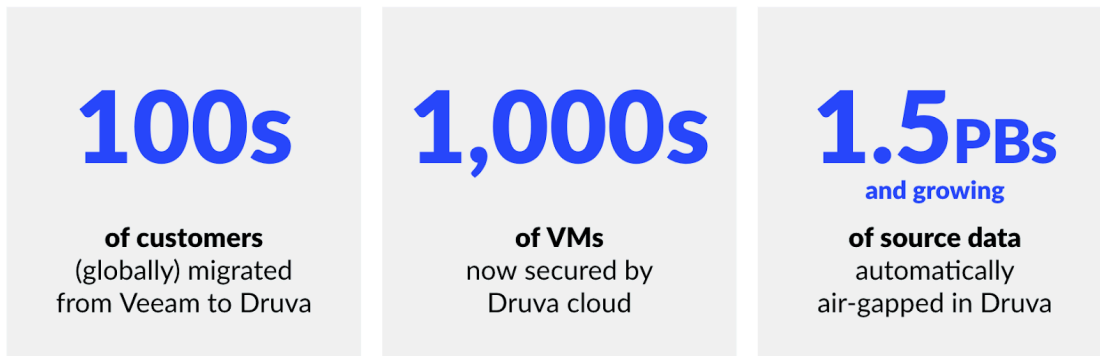
